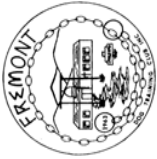

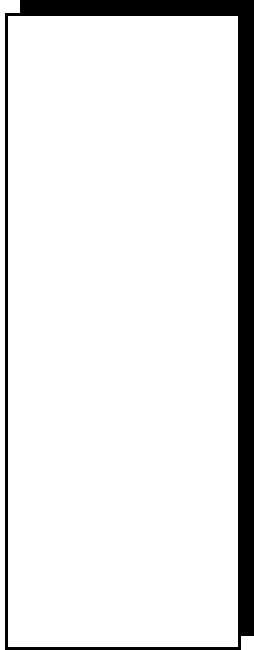

Soccer Practice Field (Parking Lot N)

The Trial will be held on the **Soccer Practice Field** at Cal-State East Bay in Hayward (Parking Lot N). There is to be **NO DRIVING ONTO THE GROUNDS**. Be prepared to haul your equipment along a paved walkway to the trial site. Limited shaded areas are available under trees for setups. Handlers may want to bring canopies to protect your dogs.

From Oakland Area, Take Highway 580 Eastbound to Hayward and exit on the Hayward exit. Continue on Foothill Blvd into downtown Hayward. Turn right onto "A" Street, two blocks, left onto Mission Blvd for several blocks. Turn left onto Carlos Bee Blvd, go up hill, and stay to the far right to enter the campus. Turn right into **PARKING LOT N** for Practice Soccer Field.

From San Jose Area, take Hwy 880 North to Hayward. Exit on the Jackson Street exit eastbound. Continue straight on Jackson to downtown Hayward. Turn right onto Mission Blvd for several blocks. Turn left onto Carlos Bee Blvd, go up hill, and stay to the far right to enter the campus. Turn right into **PARKING LOT N** for Practice Soccer Field.

From SF Peninsula, take the San Mateo Bridge (Hwy 92) east to Hayward. Continue past the intersection with Hwy 880. Continue straight on Jackson to downtown Hayward. Notice To Exhibitors

1. **CONDITIONAL, UNSIGNED, INCOMPLETE, or telephoned, entries cannot be accepted.** Entries without fees cannot be accepted. **ENTRIES NOT ON OFFICIAL AKC FORMS** or photocopies of entry forms without the agreement and rules on the reverse of the Official AKC entry forms are **NOT ACCEPTABLE.**
2. **CHANGES, ADDITIONS, OR CORRECTIONS** to entry forms must be received **IN WRITING** prior to close of entries. Email and faxed changes are acceptable. Telephone changes are not acceptable. **OWNERS ARE RESPONSIBLE FOR ERRORS** on entry blanks, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such entries.
3. An AKC RECORDING FEE of \$.50 first entry only and an AKC EVENT SERVICE FEE of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.00 will be required for each entry in an AKC Member or Licensed Rally Trial. All Recording and Event Service Fees are paid to the American Kennel Club.
4. **ENTRY FEES WILL NOT BE REFUNDED** in the event of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian, or Judge, or barred from competition by the Trial Committee.
5. **BITCHES IN SEASON** are not permitted to compete in Obedience or Rally classes. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. **A processing fee of \$10.00 per entry will be retained.** A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.
6. **THE WELL-BEING OF DOGS** and participants is of paramount importance. If, because of riots, civil disturbances, fire, Act of God, act of a public enemy, strikes, extreme weather conditions (including but not limited to extreme heat, floods, hurricanes, lightning, or earthquakes), or any other acts beyond the control of the management, it is impossible to open or complete the trial, no refunds of entry fee(s) will be made. **DO NOT LEAVE ANIMALS IN A HOT VEHICLE.**
7. **CONFIRMATION OF ENTRY AND SCHEDULE OF JUDGING TIME** will be sent to the address on the official AKC entry form after the closing date. If an exhibitor has not received a copy of the Schedule within seven (7) days of the show, the Trial Secretary should be contacted.
8. Consult Judging Program for time of judging. **DOGS MUST BE READY FOR JUDGING.** The Club and/or its Trial Secretary will not be responsible for and are not obligated to furnish any service for notifying exhibitors or their agent of class judging. Judges will not wait for any dog holding up a class. Owners or their agent alone are responsible for the timely presence of their dogs in the judging ring. Dogs may be excused from the trial after their class has been judged, if not eligible for further judging or awards.
9. **THE TRIAL-GIVING CLUB, THE TRIAL SECRETARY,** their agents or employees assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs or property, and further assume no responsibility for injury to any child not under the control of their parents or guardians.
10. **ALL AWARDS MUST BE CLAIMED THE DAY OF TRIAL; NONE WILL BE MAILED.**
11. **CLASS TRANSFERS ("MOVE-UPS")** will be permitted provided space is available in the class, and provided the Trial Secretary is notified in writing at least 30 minutes prior to the start of the trial.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.**

INSTRUCTIONS

- (Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in. over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries close after the date acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 11, Section 3).
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
